#### **FIREWORKS**

Sacramento County encourages residents to be safe when using fireworks this Fourth of July season. The unsafe use of fireworks can cause severe burns, amputations, blinding, and even death. Damaging fires occur when children use fireworks unsupervised by adults. Parents are responsible for any property damage or injuries caused by all fireworks. Follow these tips to ensure your celebration is safe for everyone:

#### **KEEP IT LEGAL**

- All legal fireworks in California are called Safe and Sane Fireworks and must bear the State Fire Marshal's seal.
- Safe and Sane Fireworks may only be sold through 9 PM on July 4th.
- Safe and Sane Fireworks may only be used between 9:00 AM to 10:00 PM through July 4th.
- Any firework that goes up in the air or explodes is illegal and dangerous.

#### **KEEP IT SAFE**

- Always have a bucket of water to dispose of fireworks and leave soaking overnight before disposing.
- Always have a hose connected to water available in case of fire.
- Do not use fireworks near dry grass or other flammable materials.
- Do not use fireworks while under a canopy, covered balcony, covered patio, or under a tree or bushes.

#### SOCIAL HOST ORDINANCE

On June 24, 2022, in response to increase in illegal fireworks, the Board of Supervisors <u>adopted an ordinance</u> to add host liability and penalties for violations of the county code. "Host," as it relates to this ordinance, means a person who knowingly permits or allows fireworks to be lit, exploded, or sold on private property owned or

controlled by the person, and the person knows or reasonably should have known that the fireworks would have been lit, exploded, or sold.

Amending Sacramento County Code Chapter 4.54 created new host responsibilities that include liability and penalties with increased fines for violations of the county code relating to Fireworks and provides an additional tool for reducing the harm caused by using illegal fireworks. Penalties for violations are as follows:

- \$1,000 for the first violation
- \$2,500 for the second violation within one year of the first violation
- \$5,000 for each additional violation within one year of the first violation
- \$10,000 for each violation that occurs at schools, parks and within the American River Parkway

The ordinance to add host liability for illegal fireworks allows fire, law enforcement (including Park Rangers), and Code Enforcement agencies to hold the owner or person in charge of real property or conducting an illegal fireworks event responsible for the costs of response associated with the presence of emergency personnel, the discharge of illegal fireworks on private property or the American River Parkway, and any aiding and abetting the discharge of illegal fireworks.

#### **ILLEGAL FIREWORKS ARREST**

As many of you know, I have been working with the Sheriff's Office, Sac Metro Fire, Code Enforcement, and many others to stop the proliferation of illegal fireworks in Sacramento County. Illegal fireworks are extremely dangerous, cause devastating wildfires, and disrupt the peace and quiet of our neighborhoods. I am happy to share the following press release about the arrest of a major distributor of illegal fireworks in Sacramento County. I will

personally talk to District Attorney Thien Ho to encourage his office to prosecute the individuals involved and seek the strongest penalties available.

Sacramento County Sheriff's Central Division Problem-Oriented-Policing (POP) Deputies and Investigators from the Sacramento Metropolitan Fire District received an anonymous web tip provided by concerned citizens within Sacramento County about an online advertisement for illegal fireworks posted on social media. An investigation was conducted and a search warrant into a residence on Emory Court in South Sacramento was authorized.

The Sheriff's Special Enforcement Detail executed the search warrant at the residence, resulting in a significant seizure. The operation yielded nearly 8000 pounds of illegal fireworks, five firearms, and over \$20,000 in cash. This successful outcome is a testament to the collaboration of our agencies and the concerned citizens who provided the tip.

All legal fireworks in California are called Safe and Sane Fireworks and must bear the State Fire Marshal's seal. Safe and Sane Fireworks may only be sold through 9 PM on July 4th and may only be used between 9:00 AM to 10:00 PM through July 4th. Any firework that goes up in the air or explodes is illegal and dangerous.

#### **BUDGET RECAP**

The Sacramento County Board of Supervisors voted unanimously on June 5 to approve the \$8.8 billion Recommended Budget for Fiscal Year (FY) 2024-25.

The \$8.8 billion spending plan consists of \$3.5 billion in Enterprise and Special Revenue Fund appropriations (utility rates, fees and other dedicated revenue), \$3.8 billion in General Fund appropriations (funded with \$990 million in discretionary resources, \$1.5 billion in reimbursements from restricted funds, and the remaining

\$1.3 billion in Federal, State and fee revenue dedicated to specific purposes), and \$1.5 billion in Restricted Funds.

The Recommended Budget recognized new or enhanced areas of growth, including:

Health Services increased by \$28.4 million for increased acute psychiatric inpatient costs, Behavioral Health Bridge Housing funding, increased capacity and services at Permanent Supportive Housing units, and behavioral health services at the Youth Detention Facility.

Child, Family and Adult Services increased by \$5.7 million (\$4.5 million Net County Cost) for Child Protective Services welcome and assessment center services and family resource center court-mandated parenting workshops.

**Human Assistance** increased by **\$4.2 million** (\$100,000 Net County Cost) for childcare payments for CalWORKs participants and funding for a position in the County Veterans Services Office.

**Sheriff** increased by **\$3.9 million** (\$1.2 million Net County Cost) for a mobile command vehicle, required software expenditures and required body-worn camera licenses and equipment.

Correctional Health Services increased by \$3.4 million (\$300,000 Net County Cost) for a Medication Assisted Treatment Program, additional pharmacy positions (both of which support the County's obligations under the Mays Consent Decree Remedial Plan) and a new electronic health record system.

**Community Development** increased by **\$1.2 million** (\$1 million Net County Cost) to support the Infill Acceleration Program, the Climate Action Plan and two Planning Technician positions.

Homeless Services and Housing increased by \$1 million (before reimbursements) to fund beds at a planned Safe Stay Community and three new positions and services supporting administration for the department.

This year's reductions totaled \$6 million, which will result in the deletion of 31 vacant full-time equivalent (FTE) positions as well as other budget reductions across several departments. No filled positions were recommended for deletion.

The Recommended Budget's most significant reductions include:

**Health Services** reduced by **\$2.2 million** including consulting contracts, operational supplies and the deletion of 14 vacant FTE positions.

**Child, Family and Adult Services** reduced by **\$1.8 million**, including the deletion of 16 vacant FTE positions.

In addition to staff recommendations, the Board added two full-time equivalent positions: a criminal attorney in the District Attorney's office and a criminal attorney in the Public Defender's Office. The funding for those two positions will come out of the appropriation for contingency, reducing that appropriation from \$15.1 million to \$14.5 million.

The Board also supported a three-year funding commitment to the Black Child Legacy Campaign in future budget recommendations through Fiscal Year 2026-27.

#### NO DRINKING IN THE PARKWAY

Visitors to the American River Parkway are permitted to consume or possess alcohol in designated areas, **but there are permanent alcohol bans at specific locations including:** 

- The bluffs near Old Fair Oaks Bridge
- El Manto river access
- Sarah Court River access
- Paradise Beach recreation area
- Discovery Park
- Tiscornia Beach
- Sutter's Landing

Additionally, during 4<sup>th</sup> of July, Labor Day weekend, and Memorial Day weekend, alcohol is temporarily prohibited along the Parkway between Hazel and Howe Avenue, as well as at Sherman Island. Glass beverages are prohibited throughout the year along the Parkway. It's important to note that alcohol and water sports are not a safe mix, as alcohol can impair judgement and lead to risky decisions. Read more about staying safe on the water. Learn how to
