"The greatest danger in times of turbulence is not the turbulence; it is to act with yesterday's logic." - Peter Drucker

There is an ancient Chinese proverb that says, "may you live in interesting times." No sooner was it coined than began the scholarly debate whether it was intended as a blessing or a curse. Whichever way you see it and regardless of how you feel about it, the important thing is to figure out how to navigate effectively through the turbulence. I have been busy trying to do just that.

The Delta Counties Coalition, that I happen to chair, is made up of the five county supervisors whose Districts touch the Sacramento-San Joaquin Delta – Sacramento, Yolo, San Joaquin, Solano and Contra Costa. We will be flying back to DC later this month to meet with Representatives and Administration officials to encourage investments in common sense solutions for the Delta. Regardless of the personal rift between the President and the Governor, my goal is to leverage their ambition to deliver to our advantage through Delta conveyance, rather than continuing to pursue the building of a bypass tunnel.

Speaking of the Delta, I have been working with the communities there to communicate with Caltrans the need to have a more accommodating closure schedule for the bridge repair work they are doing this year. Fun fact: did you know that the Isleton and Paintersville Bridges were both designed by Joseph Strauss? He also designed a slightly more famous bridge downstream called the Golden Gate. Unfortunately, this significance means that they are both listed as National Historic Monuments which makes the repair work much more delicate and restricted. Hopefully, we will be able to come to a solution that has the least impact on the movement of goods and people across the river while these 101-year-old bridges are restored to their glory and safe operation.

We have also been having an interesting conversation recently about regional transportation funding. I won't bore you with the details, because it is a subject that only

nerds like me really enjoy digging into, but suffice to say that I am on the side of fighting for ensuring every dollar that should be spent in Sacramento County comes to Sacramento County. As simple as that seems, it involves our other local regional agencies, as well as both our State and Federal governments. Again, the challenge is how to figure out what message is most effective in garnering support for the projects that matter most to us.

I also had an interesting conversation with the largest private employer located in the Rosemont community. They have seen an untenable rise in crime and the impacts of homelessness, but we agreed to commit to leaning in for the community's benefit and to try and spur reinvestment. They committed to keeping the headquarters there and being an active participant in the resurrection.

My mom turns 90 this month, which is somewhat mind boggling for me to think about how many different "interesting times" she has lived through. She is an amazing woman, but if she could get through it, so will we.

California Capital Airshow



Get ready, aviation fans! The California Capital Airshow is set to take flight, bringing the legendary Blue Angels to Sacramento this month!

The California Capital Airshow, presented by Sacramento County in partnership with the City of Rancho Cordova, is coming to the historic Mather Airport in the spring this year, which will be cooler, more comfortable weather than the typical fall schedule. Celebrating their 19th year, the Airshow will be on March 22-23, 2025, and is sure to be truly spectacular!

This year's Airshow is one of a select few airshows nationwide chosen to commemorate Navy Week and the U.S. Navy's 250th Anniversary. Headlining this adrenaline-pumping weekend is the U.S. Navy Flight Demonstration Squadron, the Blue Angels, returning to Sacramento for the first time since 2019. The California Capital Airshow will serve as the Navy's keystone event, "Navy Week" (March 17-23, 2025) and we are honored to be one of only 15 host cities for this prestigious celebration.



In addition to the high-flying action, the Airshow will pay tribute to another historic milestone, the 80th Anniversary of the end of World War II. Special educational displays, live music and choreographed aerial performances featuring vintage aircraft and fifth-generation jets will be present to commemorate the anniversary of the end of World War II.



Since its founding in 2004, the nonprofit California Capital Airshow (CCA) has been committed to honoring the region's rich aviation heritage, veterans and allies, while using the magic of flight to inspire the next generation. Beyond the Airshow weekend, CCA plays an important role in the community providing scholarships, charitable donations, and innovative educational programs designed to spark curiosity

and excitement in school age kids and teenagers for careers in aviation, aerospace and STEM fields.

The 2025 California Capital Airshow promises to be a powerful and extraordinary community event paying tribute to the industry and history of aviation. I know I'm looking forward to celebrating our region's remarkable history over the Airshow weekend!

988 Lifeline



Sacramento County is committed to responding to crisis mental health calls in a way that helps provide access to critical services. I want to share some information about the resources available to you if you, or a loved one, are experiencing emotional distress or a substance abuse crisis. With rising levels of anxiety, depression, emotional distress and overdose-related deaths, it is crucial that we provide somewhere to turn when someone is in crisis.

Simply calling or texting 988 or visiting 988lifeline.org will connect you to an experienced and compassionate person who can provide free and confidential emotional support 24 hours a day, 7 days a week. The staff at 988 are extensively trained counselors who can also assist with suicide risk assessments, explore stressors, help identify coping skills and available resources, collaborate on safety planning and provide follow-up calls.

The [988 Lifeline](https://988lifeline.org) is a direct connection to immediate support and resources for anyone in crisis.

If an in-person response is needed, the Sacramento County Community Wellness Response Team (CWRT) also responds to calls from 988 for people who may benefit from in-person crisis intervention. Available 24 hours a day, 365 days a year, anyone can receive a CWRT response by calling or texting 988. The 988 specialists will initiate a three-party call with a CWRT Dispatcher. The Dispatcher will then take the lead on the call and ensure the CWRT response team meets with you at your location which can be home, a park, a library, etc.

And it works! About 98% of people who call, chat or text the [988 Lifeline](#) get the crisis support they need. If you need someone to talk to or someone to respond, 988 is a safe place to get the help you need. There is hope and this information can help.

County Boards and Commissions

Community service starts close to home but opportunities to serve may not always be so easy to find. Being a member of one of the Sacramento County boards or commissions is an excellent opportunity for residents with a strong commitment to community service to directly influence important decisions and policies that impact their neighborhoods and beyond. It offers you a chance to address critical issues affecting your community while helping shape the future of Sacramento.

I encourage you to apply for a seat on one of the over 70 boards and commissions in Sacramento County. There are a range of interests covered by the many different planning commissions, advisory boards, cemetery districts and appeals boards in Sacramento County. There's something for everyone, from youth, aging and senior issues, mental health, and substance abuse, to housing, veterans and the environment.

For the younger members of our district, there are a few seats available on the Behavioral Health Youth Advisory Board and the Sacramento Youth Commission, both providing an excellent opportunity for young people to have a voice in local government while getting started on a path of civic engagement.

We are always looking for passionate and dedicated folks who want to contribute their unique perspective and lived experiences to help shape the local decision-making process. CALTRANS DELTA BRIDGE PROJECTS UPDATE
