- Universal Waste (household batteries, fluorescent light bulbs less than 4', and cell phones)*
- Tires (no rims; maximum of 5)*
- Furniture/Mattresses
- Pipes
- Lumber
- Lawn/Tree/Shrub Trimmings
- Junk
- Containerized Glass

Lumber, pipes, and trimmings shall not exceed FOUR inches in diameter and FIVE feet in length.

UNACCEPTABLE MATERIALS

- Dirt, Rocks, and Bricks
 - Glass Panes
- Concrete
- Vehicle Batteries
- Household Garbage
- Hot Ashes
- Heavy Materials (like auto bodies, engines, etc.)
- Hazardous Waste (like paint, oil, chemicals, etc.; this material may be dropped off at the Household Hazardous Waste Collection Facility located at the North Area Recovery Station. Call 916-875-5555 for hours.)

*Place these items to the side of your pile.

Low or NO charge

County curbside customers have one free pick up per calendar year.

Additional pickups for a pile of 5 cubic yards or less are only \$25 each. Pile size must not be more than 8' x 4' x 4' - or about the size of a pick-up truck bed filled even to the top of the cab.

This service available for businesses in the unincorporated County for only \$25 per pick-up.
